- 1.) It is the buyer's responsibility to have this puppy examined by a veterinarian within 72 hours after adoption. This is your health guarantee period. If this puppy is found to have an <u>un-treatable</u> or <u>Severe life threatening</u> disease that is felt to have been contracted at the seller's home (documentation required by a licensed Veterinarian). Seller will <u>replace</u> this puppy of equal value at the Seller's first opportunity.
- 2.) This puppy is guaranteed against all heredity defects up to the age of 3 years. Should a hereditary defect appear within the first 3 years, a Veterinarian must document it. The purchaser is obligated to immediately spay/neuter this individual. Upon supplying the seller with this documentation, seller will replace this puppy with another of equal value at the seller's first opportunity. Buyer understands that at <u>no</u> time for any reason will there be a monetary refund of any of the purchase price.
- 3.) The puppy cannot be returned after the guarantee period has expired. It is the responsibility of the buyer to provide immediate veterinary care to any puppy showing signs of illness or distress. Failure to do so will render any guarantee null and void. Except the spay/neuter is in force no matter what the condition or problem. By signing this contract, the Buyer is also signing permission for their veterinarian to disclose any and all veterinary information pertaining to this said puppy and any and all information on dogs living with said puppy. The Seller can ask which clinic and fax them a copy of this agreement to gain access, if need be. All veterinary fees are the sole responsibility of the Buyer.
- **4.)** (**Breeder ONLY**) seller guarantees fertility in this breeding animal with the exception of problems caused by pyometria which the breeder has no control over. If this dog has not produced viable offspring by the age of 4 years, after being serviced by at least two proven studs or bitches whichever the case, the Seller agrees to replace the dog with one of equal value upon proof of spay/neuter by a licensed veterinary at Seller's first opportunity. Seller does have the right to attempt to breed the dog on a BlackRiver Dog before a replacement, for proof of infertility.
- 5.) This Dog is not guaranteed against cosmetic faults, i.e. tail fault or locket. A cosmetic fault does not preclude the dog from being bred as it is not a health issue.
- 6.) No breeder male or female from BlackRiver may be sold, placed, leased, loaned, traded, co-owned or given away to another breeder, or person unless written permission is received by

the seller, Dasynda Rosenbarger with her signature. The said dog cannot leave the Buyer's possession until they are spayed or neutered.

- 7.) The buyer agrees to provide adequate and safe containment for the puppy/dog this includes heavy duty thick gauged chain link or cattle panels with at least 8 foot high fencing, lean ins, and dig guards. 6 FT fencing is allowed **if** the top of the containment is completely covered and secured with heavy duty fencing. The containment must be large enough for the dog to exercise and play comfortably.
- 8.) The buyer understands that wolfdogs are not legal in some states and counties. The dog/puppy must never live or be housed in an illegal county/state/city.
- 9.) All puppies purchased as pets must be spayed/neutered by 18-24 months old. Permanent ownership of this dog is reliant upon your compliance with this contract. Proof of the spay/neuter must be received by the breeder within fourteen 14 days after the surgery. In the event that the dog's health does not allow this agreement to be honored, BlackRiver Kennels must be provided with a statement from your veterinarian that this dog is not yet in physical or emotional condition for surgery. Based upon the veterinarian's evaluation of this dog the (buyer) will contact the veterinarian and establish the earliest date that the procedure can be performed. (buyer) will notify the breeder of this amendment in writing, at which time all other conditions of this agreement will apply and be enforced. This is the responsibility of the buyer, not the veterinarian, to ensure that BlackRiver Kennels has received verification that the surgery has been performed. A copy of the medical record as well as the receipt is necessary verification along with the veterinarian's phone number to follow up about procedure. Failure to comply with this agreement by the date below, unless otherwise agreed to in writing, will be considered a breach of the Contract, and buyer will transport this dog back to BlackRiver Kennels and will not be entitled to a refund. Buyer will also be fined \$1,000, the difference between pet price and breeding price.

By my signature below, I agree to have this dog spayed/neutered by the age of 18-24 months_and I understand that this spay/neuter agreement is an agreement that this dog will not produce a litter of puppies either as purposely bred or by accidental breeding. I also agree that should puppy not be **SPAYED/NEUTERED** by two years of age that I will return said puppy back to the seller/breeder with no refund or face \$1,000 fine.

If Buyer or Seller commences any legal action as a result of this contract, Buyer agrees that the place of venue for such action shall be the state of Indiana in Clark County. Any legal fees incurred in upholding this contract will be paid by the Buyer. This contract is legally binding to all parties named within and applies to only the buyer and the seller named below and is not transferable to other parties. If the buyer sells dog to a 3rd party, the health contract is Null and Void, however the spay/neuter agreement is still applicable.

****Should any slander, causing any type of damage to the reputation of BlackRiver Kennels and/or its owner, resulting from any disputes associated with this agreement and the aforementioned dog, or should any part of this contract be violated, the Buyer agrees to pay fines of \$10,000 in addition but not limited to, collection costs, attorney fees, court costs and all other expenses of enforcing the rights of the Seller under this agreement. Defamation, slander, accusation are inclusive of, but not limited to all social media platforms.
